Notes for TEA Candidates

What is the TEA test?

- TEA is a test of your ability to communicate in English – it is not a test of your operational knowledge
- TEA is a test of plain English in an aviation context – it is not a test of aviation phraseology
- TEA is a face-to-face interview with one examiner lasting 20 - 25 minutes and consisting of 3 sections:

Section One Introduction

You will be asked a series of set, simple questions relating to your aviation background. There is no right or wrong answers – you should show you understand the questions by talking about your role in aviation.

Section Two Interactive Comprehension

There are three parts to this section. In each section, you will listen to a series of recordings presented by international speakers of English. Recordings will be played once unless you ask for repetition. You cannot hear recordings a third time. You are not allowed to write anything.

In the first part, there are 10 recordings in which a pilot or controller is talking in a non-routine aviation situation. After each recording, you should show you understand the situation by repeating the information or explaining it in your own words. All the information is important.

In the second part, there are 3 recordings in more general, non-routine situations. After each recording, you have 20 seconds to ask the speaker questions to find out more about the situation. There are no right answers, but you should show you understand the situation by asking relevant questions.

The third part is similar to the second part – there are 3 recordings in general, non-routine situations. After each recording, you have 20 seconds to give the speaker some advice. There are no right answers, but you should show you understand the situation by giving relevant advice.

Section Three Picture Description and Discussion

You will be given 2 connected pictures to describe and compare. You will be shown the first picture and asked to describe it with 30 seconds to speak. You will then be shown a second picture and asked some questions about it. You will then be asked some questions about both pictures. Finally, you will take part in a discussion of general aviation topics related to the pictures.

Who is TEA for?

TEA is suitable for professional, private or student pilots (airplane or helicopter), professional or student controllers, FISOs and radio operators. **It is your responsibility to check that your license-issuing authority accepts a TEA certificate from the TEA Centre where you take the test.**

What happens on the test day?

You should **arrive at least thirty minutes before** your test time so that the administrator can take your photograph (which will appear on your certificate). Make sure you bring the passport or national identity card you registered with to the test centre – you will not be allowed to take the test without it. You do not need to bring anything else with you. Mobile phones must be left outside the test room. The test will be recorded for security reasons. If you are unhappy about any aspect of the test day procedures, you must speak to the administrator on the test day. Your test result will not be available on the test day, so please do not ask the examiner.

What kinds of results are given?

The test is scored according to the ICAO Language Proficiency Rating Scale. You will be given a score from 1 to 6 for your performance in Pronunciation, Structure, Vocabulary, Fluency, Comprehension and Interactions. The overall mark will be the lowest of these scores. All of this information is recorded on your certificate.

When will I receive my certificate?

After your test is checked for interlocution and rating standards, your certificate will be printed and posted within 15 working days of your test date.

Prep courses and tests

Prior to taking the exam, we also offer preparation courses and BENCHMARK TEST OF ENGLISH FOR AVIATION (b-TEA), in line with our clients` needs and requirements. It is highly recommended to sit for b-TEA before starting a course as the results of this research indicate an acceptable correlation between the two tests. We are therefore able to conclude that a score of x on the Benchmark Test (b-TEA) is equivalent to a score of y on the ICAO language proficiency scale.

BENCHMARK TEST OF ENGLISH FOR AVIATION (b-TEA)

b-TEA is an on-line multiple-choice test (see link below) which assesses a candidate's English ability for benchmarking / diagnostic purposes. The test assesses a candidate's knowledge of grammar, vocabulary and listening comprehension skills. It does not attempt to assess a candidate's spoken English. This means that it cannot be used for licensing purposes but it can be a simple, cheap and fast way of assessing a large number of people in order to determine their training needs.

b-TEA is a simple, cheap and fast way of assessing and determining training needs and it is the most suitable for determining approximate ICAO levels from 2 to 5. It consists of 140 multiple-choice questions and lasts for a maximum of 45 minutes.

Technical Requirements: b-TEA is designed to be used on a desktop computer (not a phone or tablet). We recommend using the latest version of Internet Explorer, Google Chrome or Firefox. Your browser must have JavaScript activated and pop-up blockers disabled.
